#### **Minutes**

A Regular Meeting of Walterboro City Council was held at City Hall on Tuesday April 2, 2024, at 6:15 P.M., with Mayor Bill Young presiding.

City Manager Jeff Molinari, Assistant City Manager Ryan McLeod, City Clerk Adrienne Nettles, Utilities Director Wayne Crosby, Public Works Director Michael Crosby, and City Attorney Brown McLeod. Councilmember Greg Pryor was not in attendance.

#### City Manager's Report

1. Consideration of a request to purchase a generator for the Wastewater Treatment Plant Expansion Project – FEMA Grant.

City Manager Jeff Molinari stated Mr. Mayor and members of Council this morning I emailed you a memo and supporting documentation requesting approval to purchase a generator for the Wastewater Treatment Plant Expansion project. The city received a proposal for a 1500-kilowatt engine driven emergency power supply system from Source Well Cooperative purchasing program. Participation in the program is FEMA-approved and is available at no cost to local governments. The most recent projected overall budget for the project is \$1.7 million. The city has secured a grant in the amount of \$1,188,784.60 from FEMA. The proposal from Sourcewell is significantly more than what we received from FEMA through the grant. The current delivery time is between 76-84 weeks after release with the order. We are required by state law to have a back-up power supply for the wastewater treatment plant. Due to the price increase we will have to seek additional funding. Our first option will be to request additional funding from FEMA. When this project was originally designed our engineer recommended a 1300-kilowatt generator. Those generators are

no longer being produced. With that being said, we will have to go with the 1500-kilowatt generator which is more expensive. If this option is not viable there are some additional options, we can pursue through RIA or potential Skip funding. If we are unsuccessful in getting additional federal funding, we will be able to cover this through the construction contingency. That will be funded through the anticipated bond issue in July of 2025 to cover the short fall. We ask for councils' favorable consideration so we can move forward with the order because of the timing. As City Council is aware we have received two grants from EDA for construction of that project. It is imperative that we close out the expansion project in a timely manner, so we can utilize all the funding from EDA. If you have any technical questions our Utilities Director Wayne Crosby is here.

Councilmember Brown asked, do you feel confident that we can find additional funding?

City Manager Jeff Molinari stated I think we a strong case that we could possibly get more money from FEMA. As Council is aware we were successful last year with EDA. We are going to work hard through our contacts at the Lowcountry Council of Governments to do whatever we can with FEMA to get the additional funding. Worst case scenario is that if we are not funded by FEMA, we will still have the capacity to make the purchase.

WHEREAS, a proper petition has been filed with the City of Walterboro Council by 100% of the freeholders owning 100% of the assessed value of the contiguous property hereinafter described petitioning for annexation of the property to the City of Walterboro under the provisions of SC Code Section 5-3-150(3); and

WHEREAS, it appears to Council that annexation would be in the best interest of the property owners and the City of Walterboro; and



Total allocation from the State of South Carolina as appropriated by the American Rescue Plan Act of 2021 was \$2,701,301.32; and

**WHEREAS**, expenditures of SLFRF funds are required to be approved by City Council; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF WALTERBORO, SOUTH CAROLINA, IN COUNCIL, ASSEMBLED, that the following SLFRF funds, in addition to the approved expenditures included in Ordinance 2022-07 and Ordinance 2023-04 are to be obligated as follows:

- 5. 2023 Revenue Loss totaling \$40,763.00
- 6. Forest Hills Tennis Courts \$82,720.00
- 7. Water Tower Park Engineering \$21,050.00
- 8. Old Rizer Ford/Pinckney Park Storage Building Demolition \$173,000.00
- 9. Old Rizer Ford/Pinckney Park Storage Building Air Monitoring \$

**WHEREAS,** with these expenditures and interest accrued, there will remain a SLFRF balance of \$1,606,716 for future expenditures.

This ordinance shall be effective immediately.

#### INTRODUCTION

WSP USA Environment & Infrastructure Inc. (WSP) is pleased to submit this work order to provide planning and site civil engineering services for replacement of boardwalk and bridges at the Walterboro Wildlife Sanctuary in Walterboro, Colleton County, South Carolina. The proposed scope of services includes engineering design for the replacement of 11 bridges (656 linear feet [LF]), and approximately 3,170 LF of boardwalk, and maintenance of approximately 5,200 LF of multi-use path including Beach Hill Loop, Beach Hill Trail, Beach Hill Loop Observation Deck, Detriville Trail and Covered Bridge Trail. This work order contains our understanding of the project background, our proposed scope of services, fee information, project schedule, and authorization instructions.

#### PROJECT BACKGROUND

Phase 1 of this project (currently under construction) included the replacement of existing pedestrian bridges and boardwalks along Canoe Launch Trail and Hartzog Trail with Permatrak® precast concrete boardwalk and prefabricated bridges. The City of Walterboro (City) has requested engineering and environmental services at the Walterboro Wildlife Sanctuary for the proposed replacement of the remaining boardwalk and bridges in the Wildlife Sanctuary as noted above in this Phase 2 project. WSP understands that the City would like to install a consistent 8-foot-wide boardwalk, replace existing bridges, and restore the multi-use path accessing these facilities. WSP understands that an existing conditions/topographic survey of the existing boardwalks has not been prepared. The City would like

WSP to provide an existing condition topographic survey of the existing boardwalk, bridges, and multiuse path corridor. In addition, WSP proposes to perform geotechnical exploration in a limited number of locations to determine the optimal foundation system and at the approximate locations for proposed bridge abutments.

The subject property consists primarily of forested wetlands and upland habitat associated with the floodplains of Great Swamp and Ireland Creek.

#### **INVESTIGATIVE SERVICES**

WSP understands that an existing conditions/topographic survey of the existing boardwalks has not been prepared. The City would like WSP to provide an existing condition topographic survey of the existing boardwalk and a limited surrounding area. In addition, WSP proposes to perform geotechnical exploration in a limited number of locations to determine the optimal foundation system and at the approximate locations for proposed bridge abutments.

#### **TASK 1: SURVEY AND PROJECT INSPECTION**

WSP in coordination with our local surveyor, Atlas Surveying, Inc., will provide a topographic survey of the areas identified in the Introduction section above with a one-foot contour elevation, underground utilities, large tree locations and existing conditions survey. Existing conditions will include natural and man-made features located within the survey corridor. This may include, but not be limited to: buildings, fences, parking areas, pavement, impermeable features, and utilities and appurtenances that are apparent by visual inspection. Above-ground features within 10 feet of and including the boardwalks and bridges will be located. Trees larger than 4 inches (Diameter at Breast Height) within 15 feet on both sides of the boardwalk, bridges and multi-use path will be located. Flood elevations and full pool water elevations will be noted. Survey will be limited to the above noted boardwalks, bridges, and multi-use path. The survey will be certified in accordance with South Carolina requirements.

In addition to the survey, two senior WSP staff, representing environmental and engineering, will walk the work areas with City Staff to identify areas of special concern or where changes to the current alignments might occur. WSP will Global Positioning Systems (GPS) the paths gathering current condition assessment and make recommendations for maintenance or improvements by issuance of a post-walk report.

#### **TASK 2: GEOTECHNICAL EXPLORATION**

WSP proposes the following scope of services for the geotechnical exploration based on our understanding of the project and our experience with the Phase I portion of the project. Once the project design has progressed and WSP has an opportunity to visit the site to observe site conditions, WSP may adjust our proposed scope of services based on areas in which potential settlement of the boardwalk structure may have occurred and for drill rig access limitations. Based on our understanding of Phase II of the project, it is our understanding that 11 bridges will need to be replaced.

Based on our review of aerial images, six bridge locations (Covered Bridge 1, Covered Bridge 2, Deterville 1, Deterville 2, Beach Hill 1 and Beach Hill 7) will likely be accessible along or near gravel access pathways with a drill without needing any site clearing. If site clearing is required, this may constitute a change in scope. The remaining bridge locations are not likely accessible using a drill rig without the need for clearing or significant disturbance of the natural ground surface.

As such, at the six drill rig accessible locations, WSP currently proposes to perform a total of six Standard Penetration Test borings using hollow stem augers and/or mud rotary drilling equipment in general accordance with ASTM D1586. The borings will be advanced to depths of up to 40 feet. Soil samples will be obtained at 2.5-foot intervals to a depth of 10 feet and at 5-foot intervals thereafter to termination depth of the borings. Collected samples will be placed in sealed containers. Depending on the subsurface conditions encountered and planned structural loading, these bridge structures will require a deep or intermediate foundation system to support the structures. The Phase I bridges and boardwalk system to be constructed in the near future are going to be supported on a Fuller pile system (grouted helical pile intermediate foundation system).

In other areas of the proposed Phase II project not accessible with a drill rig without the need for clearing or significant disturbance of the ground cover WSP proposes to use less intrusive and disturbing hand equipment such as sounding rod or hand auger/dynamic cone penetrometer testing. WSP proposes to perform the steel sounding rod tests to a depth of up to 10 feet at 10 test locations spread out across the rest of the project not accessible using a drill rig. WSP will attempt to perform these borings, where accessible, at/near locations identified within the provided structural assessment report as indicating potential settlement of the existing structure support posts.

The steel sounding rods will be advanced with equipment in general accordance with South Carolina Department of Transportation subsurface investigation procedures. The 0.5-inch diameter steel sounding rods come in sections and are sacrificially left below the ground surface at the completion of testing as part of the test method. The soil consistency will be measured with a sounding rod to provide an indication of the density and strength of the foundation soil.

The borings/sounding rod tests will be advanced to the assigned depths or until refusal, whichever occurs first. Therefore, up to 240 lineal feet of SPT drill rig drilling and 100 feet of sounding rod tests are proposed.

WSP intends to place the borings as close to the planned bridge locations as site access allows. Offsetting of the borings may be needed due to overhead and/or underground utility conflicts, vegetation, or due to being in areas in which standing water, soft soils or other obstructions present preventing access with conventional ATV track-mounted drill rigs. Activities with a drill rig will likely create some track marks on the ground specially during driving the rig offsite to the site, which WSP expects to be acceptable. WSP did not include fees related to site restoration or repair.

WSP will establish the proposed boring locations at the site using map-scaled distances from existing boardwalk site features shown on drawings provided to us and/or a handheld GPS unit. Prior to drilling, WSP will contact "SC One Call" to have the locations of public underground utilities marked at the site. Private underground utilities should be marked by others prior to our field exploration. If requested, WSP can subcontract a private utility locator to scan the proposed boring locations to attempt to locate below-grade utilities or obstructions using ground penetrating radar and electromagnetic methods prior to drilling for an additional fee. WSP is not responsible for damage to private utilities.

WSP proposes to have a geotechnical professional onsite during drilling for up to four days to observe drilling activities, classify soil samples, and provide direction to the drilling crew on which paths to take to travel between the borings. In parallel to drilling activities observation, the geotechnical professional will also perform sounding rod tests at the 10 proposed locations. WSP will select access paths using drilling equipment that will reduce disturbance and the amount of hand clearing, however, it should be recognized that some disturbance will occur. If certain areas of the site are not permissible to travel through to access our borings, WSP requests that the Owner notify us prior to field activities.

During drilling and sampling, WSP will attempt to measure the depths to groundwater, if encountered in the borings. Following the completion of drilling and groundwater measurements, the boreholes will be backfilled with the cuttings from the borings.

WSP will conduct drilling, testing, and sampling in general accordance with applicable ASTM standards. At the completion of drilling operations, WSP will transport the soil samples to our laboratory where they will be examined by a geotechnical professional and visually/manually classified according to the Unified Soil Classification System. The engineer may select up to twelve samples for laboratory classification index testing (-#200 wash, Atterberg limits and natural moisture content) in general accordance with the respective ASTM test methods.

A registered professional engineer specializing in geotechnical engineering will direct and supervise our services. A report will be provided electronically in PDF format that describes the exploration and recommendations for the site will be provided. This report will include the following:

- Summary of the field procedures and the results of the field and laboratory tests.
- A review of area and site geological conditions.
- A review of subsurface soil and rock stratigraphy.
- A plan illustrating the approximate soil test boring locations.
- Computer generated boring logs documenting conditions encountered at individual locations.
- Discussion of subsurface conditions encountered and their impact on the proposed site bridges.
- Recommendations for fill placement for new structural fills and discussion of site soils for re-use as fill.
- Recommendations for subgrade preparation.
- Discussion of anticipated foundation types, capacities, and design parameters.

The Proposed Geotechnical Exploration does not include the assessment of site environmental conditions or the presence of pollutants in the soil, rock, or groundwater of the site.

WSP has budgeted for up to 10 hours of time for extra moving time between the borings and/or for hand clearing of vegetation should site conditions require taking indirect paths between borings to access them with a drill rig, or if areas of heavy vegetation are encountered. WSP has also assumed an on-site or nearby water supply source would be available for us to use to obtain water for the drill rig without extra cost. If changes to the proposed development, unexpected site and/or subsurface conditions are encountered, and it becomes necessary to modify the exploration plan or additional effort is needed to complete our proposed scope, WSP will contact you to discuss recommended variations in the exploration plan and our fee.

Based on our current schedule, WSP can perform the soil test borings within approximately four weeks of authorization. However, the drilling is dependent on availability and schedule of the driller. WSP has assumed that field work can occur during normal weekday working hours. Drilling should be completed within four working days. The written report will follow approximately fifteen working days after the field work has been completed. After the borings have been completed and the soil samples have been reviewed by an engineer, WSP can provide you with preliminary information by telephone or email, if requested.

## **TASK 3: ENGINEERING DESIGN SERVICES**

WSP proposes to design and prepare construction documents for the replacement of the existing boardwalks and bridges as shown in the attached Exhibit A. This task includes provision of structural engineering services necessary for the design of bridge abutments and evaluation of geotechnical/structural interactions of the piles supporting the bridges and boardwalks.

WSP will design the horizontal and vertical alignment of the new boardwalks using an 8 feet clear width and specifying construction using the Permatrak® precast concrete boardwalk system and prefabricated bridges. WSP will provide boardwalk designs for up to four different conditions to include a condition with handrails, without handrails, end condition at land, and end condition at pedestrian bridge abutments. WSP will design foundations as recommended in the geotechnical report. WSP will review code requirements and provide handrails that meet code requirements as needed. The pedestrian bridges will be specified as delegated design by a prefabrication manufacturer. WSP will provide the design parameters to include design loads, width, and length for the prefabricated bridges. WSP will design the abutments to support the pedestrian bridges.

WSP will deliver milestone submittals to include 65%, 95%, and 100% design deliverables. The deliverables will consist of construction drawings with specifications and notes on the drawings. The 100% construction drawings will be signed and sealed by a Professional Engineer registered in the State of South Carolina. WSP has included time to meet with the City via Microsoft Teams to discuss comments that they may have regarding the intermediate submittal packages as discussed below.

WSP will coordinate with bridge manufacturers and the City to select a pre-engineered bridge style consistent with the bridges used in Phase 1.

Bridge and boardwalk locations and expected lengths are shown in Exhibit A.

WSP anticipates that the construction drawings will consist of the following sheets:

- General Notes
- Existing Conditions Plan/Topographic Survey
- Demolition Plan
- Overall Site Layout and Staging Plan, including horizontal and vertical alignment

- Erosion, Sedimentation and Pollution Control Notes/Details
- Structural Design Drawings
- General notes, abbreviations, and code compliance summary
- Pre-engineered bridge notes and details
- Foundation plans and details
- Concrete sections and details
- Steel sections and details
- Boardwalk details

This task includes one site visit (after WSP receives the survey) to review existing conditions, one preliminary meeting to initiate the work, one meeting after each interim submittal to review progress drawings, and one final meeting to review completed plans (a total of four meetings). WSP anticipates that these meetings will include the Client and other members of the design team. Meetings are assumed to be held remotely, last no more than two hours, and attended by two WSP staff. One round of revisions to the plans is assumed after the interim and final meetings.

Copies of final plans will be provided to the Client and applicable permitting agencies. Upon request, electronic copies (CADD [computer-aided design and drafting] files) of the grading and site plans will be made available to the Contractor for layout and quantity take-off purposes.

## **TASK 4: ASSESSMENT AND PERMITTING SERVICES**

#### **Wetland and Stream Delineation**

WSP will determine the approximate locations and extents of wetland areas within a 40-foot corridor around the bridges, boardwalk, and walkways in Phase II of the Wildlife Sanctuary project. The delineation will be based on the Routine Wetland Determination (Level 2—Onsite Inspection Necessary) method as defined in the 1987 Corps of Engineers Wetlands Delineation Manual and the appropriate regional supplement(s). This technique uses a multi-parameter approach that requires positive evidence of all three of the following:

- Hydrophytic vegetation
- Hydric soil
- Wetland hydrology

Areas exhibiting the above three wetland characteristics and/or classified as streams will be considered potentially jurisdictional waters. The boundaries will be marked in the field (flagged) with plastic survey tape. Information for US Army Corps of Engineers (USACE) wetland delineation data forms will be collected. However, no jurisdictional determination submittal will be prepared or submitted to the USACE except for the permit submittal. Jurisdictional features delineated in the field will be located by the field team using GPS for the anticipated GIS mapping, no survey of the features will be conducted.

The results of the functional assessment will be included in a map of the jurisdictional wetlands as the sole deliverable for this task. Special circumstances regarding wetlands/streams noted during the field investigation will be reported to the City via email correspondence.

#### **Desktop Cultural Resources Investigations**

WSP will conduct a limited cultural resources literature and records search for the Project Site to determine previously recorded cultural resources are located within the project area. Documents and files to be reviewed include the National Register of Historic Places (NRHP), South Carolina State archeological site files, Pickens County historic structures survey files, compliance and research reports, historic maps, and early aerial photographs. The literature and records search will be conducted at the appropriate state repositories for cultural resources information in Columbia, South Carolina. As needed, information may be gathered from other repositories. A letter explaining the results of the literature and records search will be prepared and referenced in the Prospectus. This proposal excludes further site-specific sampling, shovel testing, compliance level reports, etc. If these or other cultural resources studies are requested, then additional services under a separate proposal will be required.

#### **Desktop Protected Species**

Protected species data from the South Carolina Department of Natural Resources and the U.S. Fish and Wildlife Service will be solicited from these agencies to gather current data on endangered or threatened

animal and plant species occurring or potentially occurring on the subject tract. WSP will also gather aerial photographs and other site documents to determine changes on the site since the original work.

Following the literature and records review, WSP will conduct a preliminary on-site reconnaissance review of the various habitat types within the selected mitigation site. This scope is limited to a sampling of the on-site habitat, no site-wide evaluation, nor will site-specific protected species evaluations be conducted. If further work is necessary outside of this limited scope, WSP will disclose this information to you, prior to additional work.

If the literature and records review and the field information allow a suitable conclusion, WSP will prepare a compliance level report to be submitted with the permit package to the US Fish and Wildlife Service, describing the results of our investigations and the potential effect of the proposed project on protected species. This report will combine the results of the above-listed project area with the biological assessments conducted previously on the adjacent interchange parcels.

# **USACE Permitting**

Based on an initial site walk through, the proposed boardwalk and bridge replacement project work appears to be confined to the existing trails, boardwalks, and bridges. Existing bridges and boardwalks will be replaced in substantially the same location as the existing structures. It is WSP's understanding that neither the engineering evaluation nor the proposed project construction work will have a significant effect on waters and wetlands. However, this work must be conducted with care to follow the Nationwide Permit (NWP) (probably NWP No. 3) general and regional conditions applicable for this project. This permit requires notification to the USACE for work in wetlands. Under this same scope, WSP will also consider submittal of an application for a "No Permit Required" letter in lieu of the NWP No.3. WSP will conduct a wetland determination in the field identifying the limits of jurisdictional wetlands.

The USACE will be the lead agency in the permitting process, while South Carolina Department of Health, Environmental Control (SCDHEC), through the Coastal Zone and 401 Water Quality Certification process, will play a secondary role. Critical components of the permit application package will be avoidance and alternatives analysis, as well as a well-detailed purpose and need statement. The avoidance alternatives analysis will justify proposed impacts to waters of the U.S. and document the lack of a reasonable and feasible alternative that would achieve the goals of the project and avoid/minimize jurisdictional waters impacts. WSP will prepare and submit the Nationwide Permit(s) authorization request application. This evaluation will include results of wetland delineation, desktop protected species, and desktop cultural resources investigations. No field surveys, except for wetlands delineation, will be performed under this task.

WSP will prepare permit drawings for the proposed project for submittal to the USACE, along with plans of impacts to jurisdictional waters, pursuant to NWP submittal. The developed permitting plans will show the proposed improvements and provide the jurisdictional waters impacts within the project

boundary. This permitting task does not include any additional drawings, engineering work, modeling, or calculations, except as specifically outlined in this work order.

WSP and the City will explore opportunities to minimize jurisdictional waters impacts where feasible, in concert with the proposed project requirements. The City will assist WSP in developing a detailed project description that will include projected direct and indirect adverse impacts to jurisdictional waters resulting from project activities. The City will also assist WSP in preparation of the alternatives analysis by providing adequate justification for jurisdictional waters, including wetlands, impacts proposed for this project.

This work order assumes that direct and cumulative impacts to waters of the US will be less than 0.1 acres (including the impacts associated with a previous permit on this site), and that compensatory mitigation will not be required. If direct impacts to waters of the US are between 0.1 acres and 0.5 acres, compensatory mitigation would be required. No mitigation planning is included in this work order. If an individual permit application is required, WSP will provide a proposal for additional services.

#### **Land Disturbance Permitting and SCDHEC-OCRM CZC Assistance**

The land disturbance permit in this work order will only cover Phase 2, which will include replacing the remainder of the existing pedestrian bridges and boardwalks as stated above. Because existing bridges and boardwalks in Phase 2 are also planned to be replaced in substantially the same location as the existing structures, land disturbance impact associated with these replacements will be limited, but is expected to be more than one acre, which includes site access, site laydown, and work along the existing trail alignments. Access to the sites will primarily be along existing roads/trails and no land disturbance to those trails is anticipated. The preliminary estimate for land disturbance is 2.8 acres (this estimate assumes 25 feet of disturbance width along the alignment of the bridges and boardwalks which are being replaced.

WSP will prepare a stormwater pollution prevention plan (SWPPP) for a project with an estimated 2.8 acres of land disturbance. WSP will prepare applications and provide subsequent support to the City to obtain state and local land disturbance permits and SCDHEC Office of Coastal Resource Management Coastal Zone Consistency certification, as required. WSP will also provide the City with electronic drafts of permit applications for review and signature prior to submittal to the agency. The Comprehensive Stormwater Pollution Prevention Plan (C-SWPPP) and Notice of Intent (NOI) will be prepared in accordance with the SCDHEC C-SWPPP template and local and SCDHEC regulations. The C-SWPPP will include:

- Construction Stormwater Best Management Practices
- Construction sequence
- Limits of disturbance
- Temporary stabilization measures
- Construction details
- Other items requested by regulators to support the NPDES permitting application.

# **Hydraulic Analysis and No Rise Report**

The results of the hydraulic analysis will be documented in a hydraulic report. The report is intended to be shared with local and state floodplain officials to show the boardwalk will comply with a No-Rise condition. WSP assumes that the proposed replacement will not require additional survey or the submission and approval of a Conditional Letter of Map Revision (CLOMR) or Letter of Map Revision (LOMR). If it is determined that additional survey, a CLOMR, or LOMR is required, a separate scope and fee will be required.

The City is requesting WSP conduct a hydraulic analysis and No-Rise report for the planned Phase 2 of the Walterboro Wildlife Sanctuary bridge and boardwalk replacements. The planned Phase 2 repairs are located within the floodway of Great Swamp and Ireland Creek.

WSP will utilize the Great Swamp hydraulic model used in Phase 1 of the project to review the planned Phase 2 repair work. The hydraulic model will be used to review flood elevations within the project site. In addition, for the Covered Bridge 1 and 2 section, the Ireland Creek hydraulic model will be used to review this crossing because it is within the floodway of Ireland Creek.

Available topographic data in the form U.S. Geological Survey (USGS) Digital Elevation Models (DEM) information will be used to supplement the cross-section geometry in the hydraulic model. Additional cross-sections may be added to the model to allow for review of the project area. A proposed conditions model run for Great Swamp representing the Phase 1 (currently under construction) and Phase 2 boardwalk replacement work will be created to compare to the existing boardwalk condition. Similarly, a proposed conditions model run for Ireland Creek representing the Covered Bridge 1 and 2 section board walk replacement work will also be created to compare to the existing boardwalk condition in this area. For this study no new hydrologic analysis will be performed and the effective discharges will be used from the Colleton County Flood Insurance Study.

The results of these hydraulic analyses will be documented in a Phase 2 hydraulic report. The report is intended to be shared with local and state floodplain officials to show the Phase 2 boardwalk will comply with a No-Rise condition. WSP assumes that the proposed replacement will not require additional survey or the submission and approval of a CLOMR or LOMR. If it is determined that additional survey, a CLOMR, or LOMR is required, a separate scope and fee will be required. This hydraulic report would be invalidated if the project timeline is extended and development within Great Swamp or Ireland Creek were to change.

#### **ASSUMPTIONS**

- The proposed boardwalk and bridge replacement project work will be confined to the existing trails, boardwalks, and bridges.
- Direct and cumulative impacts to waters of the U.S. will be less than 0.1 acres.
- Cumulative land disturbance impacts (both Phase 1 and Phase 2) not exceed 5 acres.

- Property access to the site is unrestricted and will be made available for all site visits, including geotechnical investigation, and our field work can occur during normal weekday working hours.
- A hydrology study of the boardwalk replacement is not included. Utility design and/or coordination is not included.
- Utility location will be the responsibility of the Contractor.
- WSP has not included construction administration; however, WSP can provide a proposal at the
  request of the City for these services under a separate work order. WSP will submit three
  deliverables to the City for review and comment, 65%, 95%, and 100% final design providing
  electronic (i.e., PDF) copies for each submittal. No permitting (time or fees), retaining wall
  design, or other services not specifically listed herein are included.
- WSP will design one set of abutments to be used at each pedestrian bridge location.
- Specifications will be made by reference on the drawings. A standalone specification package will not be included in the deliverables.
- The prefabricated pedestrian bridges will be a delegated design by others that will require calculations and construction drawings signed and sealed by a Professional Engineer registered in the State of South Carolina.
- Structural team will not visit the site but will be provided sufficient information from the civil and geotechnical engineers and from the survey team to complete the design.
- SCDHEC land disturbance permitting fees are anticipated at approximately \$600, and will be the expense of the City, not included in this scope/fee.
- Permits may expire and need to be renewed at the Owner's expense if construction phasing extends beyond the permit period.
- An individual permit for wetlands is not included.
- Separating the project into additional phases may incur additional.

WSP made the above assumptions in preparing this work order. WSP shall be notified if any of these assumptions are incorrect so that WSP can modify our work order accordingly.

#### **EXCLUSIONS:**

Services not specifically mentioned herein are excluded from this scope of services. The following services are clarified as exclusions from this work order, but WSP could provide them upon request at an additional fee.


- Stormwater storage facilities
- Improvements to existing roadways
- Retaining wall design
- Review and permitting fees
- Construction testing and erosion control monitoring
- Construction administration services
- Construction observation services
- Detailed cultural and protected species surveys/reports
- CLOMR and LOMR.

WSP can provide the services listed above, along with full construction administrative services for an additional fee. Construction administrative services available include bidding support, contractor management, site inspections, pavement and material testing, contractor submittal reviews, contract administration, and many other full-service options.

#### **SCHEDULE:**

WSP can commence the services proposed herein within 10 business days of receipt of the attached signed work order (as defined below). WSP anticipates the duration provided below for each phase of design and will notify the City of changes that could significantly impact this schedule. Note that USACE permitting can often take 60 days or more and DHEC permitting 180 days or more from submittal, but WSP will attempt to submit early in the design process to reduce delays due to regulatory approval.
